\*\*\*\*\* A **Building Coordinator** is a Coordinator that is responsible for gathering all of the evacuation forms (magenta colored) at the emergency exits of multi-storied buildings being evacuated, and insuring that these forms are turned in to the responding fire/law enforcement agency Incident Commander (or designee), so that it is known where, within the evacuated structure, people are awaiting professional rescue.
